SELECTION OF CANDIDATES FOR THE ACADEMIC MASTER'S AND DOCTORAL COURSES IN THE POSTGRADUATE PROGRAM IN MEDICAL SCIENCES FOR THE SECOND ACADEMIC TERM OF 2025.

1. PREAMBLE

- 1.1 The Coordinator of the Postgraduate Program in Medical Sciences (PPGCM) of the Faculty of Medicine of the University of Brasília (UnB), in the use of her legal attributions, makes public and establishes the rules of the selection process for filling vacancies in the Academic Master's and Doctorate courses of the Postgraduate Program in Medical Sciences (PPGCM), in accordance with the requirements of the Regulations of this program and Resolutions No. 80/2021, No. 44/2020 and No. 90/2022 of the UnB Teaching, Research and Extension Council, Resolutions No. 05/2020, 06/2020 and No. 11/2020 of the UnB Research and Postgraduate Chamber.
- 1.2 The Board of the Graduate Program in Medical Sciences (PPGCM) approved this call for applications at its 4th Ordinary Meeting held on 06/11/2025 and the Research and Postgraduate Board of the University of Brasilia.
- 1.3 Information about the Program and Courses can be obtained on the PPGCM website, ppgcienciasmedicas.unb.br, or requested by emailing cienciasmedicasfm@unb.br. br.

2.4 Annex I of this notice lists the areas of concentration, lines of research, and topics for which places are available in this selection process.

3 REGISTRATION FOR THE SELECTION PROCESS

- 3.1 Candidate registration for the selection process for admission in the second academic term of 2025 must be carried out exclusively *online*, from 00:00 on 06/20/2025 until 23:59 on 06/29/2025, on the following website: inscriçaoposgraduacao.unb.br.
- 3.2 The instructions for *online* registration can be found in Annex VI of this notice.
- 3.3 Applications submitted by post will not be accepted.
- 3.4 Applicants residing in Brazil or abroad may apply. Candidates with permanent residence abroad have a specific number of places, as set out in item 2.2 of this notice, and will be selected following items 4.3 and 5.
- 3.5 Candidates who are in the process of concluding an undergraduate course may apply for

a Master's vacancy, provided that they complete their undergraduate course by the first day of the academic term in which they enter the intended course, in accordance with the Academic Calendar approved by the Teaching, Research and Extension Council (CEPE-UnB), in compliance with the requirements of item 3.6.2.1 of this notice.

- 3.5.1 To apply for the PhD vacancies, the candidate must: be a graduate of a Master's degree course in Life Sciences or related areas recognized by CAPES; or be in the process of completing a Master's degree course, provided that they complete their Master's degree by the first day of the academic term in which they enter the intended course; or have compatible scientific production (article published or accepted for publication in an indexed journal, classified at least as *Qualis* A3 by Qualis Capes 2017-2020) and in the area of knowledge of the PhD project, duly proven; or have a degree in Medicine with Medical Residency completed or to be completed by July 2025.
- 3.6 Registration will take place on the website <u>inscricaoposgraduacao.unb.br.</u> It must be filled in electronically, and proof attached in relation to items 3.5, 3.5.1, and 3.6.1 to 3.6.8.
 - 3.6.1 The application form duly completed according to the standard model in Annex III of this notice.
 - 3.6.2 Depending on the intended course, the following documents must be submitted:
 - 3.6.2.1 For the Master's application: copy of the undergraduate diploma (front and back) or declaration of probable graduation in the first academic term of 2025. Applicants should know that they can only enroll in the Master's course of the Postgraduate Program in Medical Sciences with proof of completion of their undergraduate degree.
 - 3.6.2.2 For the PhD application:
 - a) Copy of the Master's degree diploma in Life Sciences or related areas (front and back) or declaration of probable graduation from a Master's degree course in Life Sciences or related areas by the first academic term of 2025. Applicants should be aware that they can only enroll in the Postgraduate Program in Medical Sciences with proof of completion of an institutionally recognized Master's degree, or
 - b) Medical residency completed or to be completed by July 2025 Copy of the Certificate of Completion or equivalent document from the Medical Residency Program, for medical candidates; or
 - c) Copy of the undergraduate diploma (front and back) or declaration of probable graduation in the first academic term of 2025 or according to the calendar established at other institutions, institutionally recognized, for candidates with compatible scientific production (article published or accepted for publication in an indexed journal, classified at least as Qualis A3 by Qualis Capes 2017-2020) and in the area of knowledge of the PhD project.
 - Applicants must know that they can only enroll in the PPGCM PhD course with proof of completion of the Master's degree and/or Medical Residency and/or undergraduate degree, according to the option in items 3.6.2.2 a, b, or c.



- 3.6.3 Research Project, according to the format established in item 4.2.1.
- 3.6.4 The Curriculum Vitae updated in Lattes format (http://lattes.cnpq.br) in the last three months.
- 3.6.5 Identity document, CPF (Individual Taxpayer's Register), Voter's Registration Card, and proof of the last vote or Electoral Clearance Certificate issued by the TSE, recent 3×4 photo, and, if applicable, Reservist Certificate, for Brazilian candidates; passport for foreign candidates.
- 3.6.6 A document attesting to the ability to understand the English language, issued by a regular language teaching institution, at a basic or instrumental level I; or a declaration issued by a regular language teaching institution attesting to having passed an English comprehension test, with a minimum score of 70% and a minimum basic or instrumental level I; or a certificate of completion of an English course, issued by a regular language teaching institution, at a minimum basic or instrumental level I (e.g. instrumental English courses, certificates issued by a language school, English language proficiency certificates).
- 3.6.7 Letter indicating the area of concentration (Medicine or Applied Health Sciences); line of research (transcribe as described in this notice); research topic (transcribe as described in this notice), and title of the candidate's project, according to the standard model available in Annex IV.
- 3.6.8 Original proof of payment of the registration fee of R\$ 150.00 (one hundred and fifty reais) for Master's candidates or R\$ 200.00 (two hundred reais) for Doctorate candidates, which must be paid via DAF on the website https://daf.unb.br/pagunbusing the following information: Service code*: 9116 28883 PUBLIC COMPETITION REGISTRATION FEE, reference number 4283 (indispensable) and Competence 01/2025.
- 3.6.9 Employees of the University of Brasilia are exempt from paying the registration fee, as are people on low incomes or from disadvantaged groups, upon detailed request, to be analyzed by the selection committee, and a manifestation of waiver of resources by the head of the Academic Unit. For the above, the low-income criterion defined by Law No. 12.711/2012 is used, i.e., it includes candidates from families with an income equal to or less than 1.5 minimum wages (one and a half minimum wages). The request for exemption must be sent to the email cienciasmedicasfm@unb.br Subject: PPGCM Notice 01.2025 full name, no later than the last day of registration for this selection process. Candidates whose exemption from the application fee is rejected may pay the fee up until July 7th, 2025, at 11:59 pm. On this occasion, the receipt should be sent to cienciasmedicasfm@unb.br Subject: PPGCM Notice 01.2025 full name.
- 3.6.10 Declaration of awareness of the limitations of orientation by the PPGCM (Annex VII).
- 3.7 By submitting the required documentation, the candidate takes responsibility for the veracity of all the information provided.



- 3.8 The selected candidates will be admitted to the respective course by registering with the Academic Administration Secretariat (SAA) of the University of Brasilia. When registering, applicants must present the following documents:
 - 3.8.1 Copies of a higher education diploma and a higher education academic record.
 - 3.8.2 For PhD candidates:
 - 3.8.2.1 Option 3.6.2.2.a: copies of Master's degree diploma and transcript of Master's degree course;
 - 3.8.2.2 option 3.6.2.2.b: copy of the certificate of completion or equivalent document of the Medical Residency Program, for medical candidates;
 - 3.8.3 Identity card; CPF (Individual Taxpayer's Register); Voter's Registration Card with most recent proof of voting or electoral discharge certificate; Reservist Certificate (male candidates residing in Brazil); National Foreigner's Registration (RNE), passport identification page, accompanied by the visa and document with the name of the candidate's parents (only for foreign candidates). According to Article 10 of Decree 9094 of 17/07/2017, "the presentation of documents by users of public services may be made through a certified copy, without the need for a new check with the original document."
- 3.9 Concurrent registration in more than one **stricto sensu** postgraduate course at UnB will not be permitted. Self-declared black, indigenous, quilombola, transsexual or transvestite applicants must check the option on the application form.
- 3.10 Indigenous candidates must attach the provisions of items 9.20 and 9.21 of this notice when registering.
- 3.11 Quilombola candidates must attach the provisions of items 9.20 and 9.21 of this notice at the time of registration.
- 3.12 Transsexual and transvestite candidates must attach the provisions of item 9.25 of this notice when registering.

4 STAGES OF THE SELECTION PROCESS

- 4.1 The selection stages will be held on the dates and times in item 7 of this notice.
- 4.2 The selection process will consist of the following stages:
 - 4.2.1 Research Project Assessment Test with Oral Argument by an examining board. The project must be written, submitted during the registration process and presented orally with the following items: introduction, justification, objectives, methodology, technical feasibility of carrying out the project, work plan, timetable and bibliographic reference, following the standards of the Brazilian Association of Technical Standards (ABNT) or Vancouver. In the scanned project material, handed

in at the time of registration, in addition to the first project cover sheet (Annex IV) and the second sheet (on a single page) with the summary of the protocol according to the model form (Annex V), the project must have between 6 (six) and 10 (ten) pages on an A4 size sheet with 1.5 line spacing and Arial size 11 font, including the bibliographical references. The title page of the project (Annex IV) must indicate the line of research and the research topic (as described in Annex I). The other pages must not contain any identification of the author or the project.

- 4.2.2 **Curriculum Vitae Evaluation Test**: This will consist of analyzing and scoring the supporting documents submitted by the candidate. The test assessment criteria are explained in item 5.3 of this notice. The scoring form must be filled in electronically during the registration procedure.
- 4.3 Stages for candidates with permanent residence abroad: Candidates must complete the stages described in items 4.2.1 and 4.2.2 of this notice, except for the oral argument stage in item 4.2.1.

5 FORM OF ASSESSMENT

- 5.1 Each of the tests (Evaluation of the Research Project with Oral Argument and Evaluation of the Curriculum Vitae) will be assigned a score from zero (0) to ten (10.0) points.
- 5.2 Research Project Assessment Test: this phase is qualifying and eliminatory. The minimum mark for passing this test is 7.0 (seven) points for the Master's course and 8.0 (eight) points for the Doctorate course. The candidate must give an oral presentation of their project in up to 10 (ten) minutes. A computer and data show projector will be available to the candidate, but she/he must assess the compatibility of her/his presentation material. The Examining Committee will use the same amount of time (up to 10 minutes) to question the candidate on the research project presented at registration. In evaluating the project, the Examining Committee will assess the candidate on the suitability of the project's study design (5.0 points); the ability to organize ideas, demonstrating objectivity and critical thinking (2.0 points); the feasibility of the project's study (1.0 point); the content of the proposal in relation to the research lines of the PPGCM Graduate Program (1.0 point); and the approval of the research protocol by the Research Ethics Committee (1.0 point, if approved; or 0.5 points will be awarded if only the submission protocol is presented). The documentation of approval or submission of the research protocol to the Research Ethics Committee, containing the Certificate of Submission for Ethical Appraisal (CAAE), if any, must be attached to the end of the research project. For candidates residing abroad, the research project will be analyzed exclusively based on the written document and scanned at the time of registration and will be based on the same criteria and scores described for the oral evaluation of the project. This phase will eliminate PhD candidates who have only presented an undergraduate diploma (front and back) or a declaration of probable graduation in the second academic term of 2025, at the time of registration, without proof of Medical Residency completed or to be completed by March 2025, or without evidence of compatible scientific production (article published or accepted for publication in an indexed journal, classified at least as Qualis A3 by Qualis Capes 2017-2020) and in the

area of knowledge of the PhD project.

- 5.2.1 About item 5.2, the score for the item "approval of the research protocol by the Research Ethics Committee" will be replaced by a score of 1.0 (one) point for the project registered with SisGen/CGen/MMA for research related to access to genetic heritage and/or associated traditional knowledge, as set out in Law 13.123/2015 (Biodiversity Law), except for projects that have already been awarded the score for approval of the protocol by the Research Ethics Committee or SisBio (item 5.2.2). The number of the respective declaration must be attached to the research project.
- 5.2.2 About item 5.2, the score for the item "approval of the research protocol by the Research Ethics Committee" will be replaced by a score of 1.0 (one) point for the authorization obtained from ICMBIO, through Sisbio, for research related to the collection of fauna, except for projects that have already been awarded the score for the approval of the protocol by the Research Ethics Committee or SisGen, and the respective registration number must be attached to the research project.
- 5.2.3 About item 5.2, for projects that do not require approval by the Research Ethics Committee or registration in SisGen or authorization in SisBio, a score of up to 6.0 (six) points will be awarded in the assessment of the item "adequacy of the project's study design".
- 5.3 Curriculum Vitae Evaluation Test: this phase is classificatory. The titles included in the CV will receive a score from 0 (zero) to 10.0 (ten). The final mark for the assessment of qualifications will correspond to the total score obtained in the evaluation, in accordance with the provisions of Annex II (Table of Points for the Assessment of Qualifications). There is a specific table for PhD candidates as well as for Master's candidates. The candidate must fill in the "Candidate's score" column with the desired score, respecting the criteria set out in Annex II. Each item for which points are requested must be proven by uploading an electronic copy (.pdf format) to the inscricaoposgraduacao.unb.br website during the registration procedure.
- 5.4 Form of assessment for candidates residing abroad: Candidates living abroad will be assessed following items 5.2 and 5.3 of this notice.

6 FINAL RANKING IN THE SELECTION PROCESS

- 6.1 The final mark for each candidate will be the sum of the marks obtained in the two tests of the selection process (Research Project Assessment Test with Oral Argument and Curriculum Analysis), in accordance with item 5 of this Notice. The maximum total score will be 20 (twenty) points.
- 6.2 All calculations to obtain the candidates' final grade will be considered up to the second decimal place, rounding up if the digit in the third decimal place is equal to or greater than five.



- 6.3 To pass the selection process, the candidate must achieve a minimum score of 7.0 (seven) points for the Master's Course and 8.0 (eight) points for the Doctorate Course in the Research Project Assessment Test with Oral Argument. Candidates will be ranked in descending order of their final marks.
- 6.4 Those candidates who, in descending order, fill the number of places offered will be selected.
- 6.5 If selected candidates withdraw, other successful candidates may be called to fill the remaining vacancies, respecting the ranking order.
- 6.6 In the event of a tie, the tie-breaking criteria will be in the following order: the highest score in the evaluation of the research project with an oral presentation; the highest curricular score; the highest score, according to the impact factor criterion (in addition to Qualis Capes 2017-2020), of publications in indexed journals in the area of Medical Sciences.
- 6.7 If the indigenous and/or quilombola candidates are not approved in the selection process, the specific additional vacancies opened in items 2.3 will be canceled.
- 6.8 If not enough black candidates are approved to fill the places reserved in item 2.2, the remaining places will be reverted to the broad competition, to be filled by the other approved candidates, according to the ranking order.
- 6.9 If there are not enough candidates with disabilities or transsexual or transvestite candidates to fill the reserved vacancies, the remaining vacancies will be allocated, as a priority, to the Affirmative Action Policy. If the admission criteria are still not met, the vacancies may be reused in the general selection process or disregarded, the decision being taken by this Graduate Program.

7.2 The results of all stages will be announced at ppgcienciasmedicas.unb.br. If the address is unavailable on the day, the results will be sent by e-mail to the addresses registered by the candidate at the time of registration.

8 APPEALS

- 8.1 Requests for reconsideration and appeals (the latter only for errors of form) will be accepted if lodged within two (2) working days of the results being announced. They must be submitted using the standard form entitled "Request for Reconsideration or Appeal in the Selection Process for Admission to Postgraduate Courses", available on the website https://dpg.unb.br/images/formulario de recurso 2023.pdf. cienciasmedicasfm@unb.br. These must be sent to the email address
- 8.2 For the purposes of appeals, candidates have the right to access recordings of any tests taken.
- 8.3 Appeals against the final results can only be lodged with the Program Board and the Research and Postgraduate Board at the Postgraduate Dean's Office in the event of a formal defect, up to 10 (ten) working days after the announcement of the Final Results, as provided for in the General Regulations of the University of Brasilia, Article 61.
- 8.4 Requests for reconsideration and appeals addressed to the PPGCM Graduate Board must be submitted by the candidate or their legal representative to the following e-mail address: cienciasmedicasfm@unb.br, with the subject line "Candidate's full name Type of request PPGCM Notice 021/2025" and the signed and scanned request in .pdf format attached.
- 8.5 Appeals to the Research and Postgraduate Board must be submitted by the candidate or their legal representative to the following email address: cienciasmedicasfm@unb.br. Thev will be sent via the SEI system to the Postgraduate Dean's Office—DPG/CPP.

9 AFFIRMATIVE ACTION VACANCIES

- 9.1 Based on CEPE Resolution No. 0044/2020, which provides for the affirmative action policy for black, indigenous and quilombola students in postgraduate courses at the University of Brasília, as well as CPP Resolution No. 0005/2020, which establishes a reserve of places for people with disabilities in the selection processes of the University of Brasília's postgraduate programs, the Selection Process for the Academic Master's and Doctorate courses provides for a reserve of places for black candidates, for candidates living abroad and for transsexual and transvestite candidates. Additional places are available for indigenous and quilombola candidates and candidates with disabilities.
- 9.2 The information provided at the registration time is the candidate's sole responsibility, who must answer for any falsehood.
- 9.3 Candidates who do not appear before the Ethnic-Racial Self-Declaration Validation Commission on the day, time and place established or who do not have their self-declaration accepted will not be able to compete for the places earmarked for Affirmative



Action Policies, but the right to appeal under CEPE Resolution 0090/2022 will be guaranteed.

- 9.3.1 The appeal must be sent directly to the email heteroidentificacao@unb.br within two (2) working days of the publication of the result of the Ethnic-Racial Self-Declaration validation procedure.
- 9.3.2 The Appeals Committee reserves the right to summon the candidate for a new face-to-face verification.
- 9.3.3 There can be no appeal against the decisions of the Appeals Committee.
- 9.4 If there are not enough successful candidates who opt for affirmative action policies for black people to fill the reserved vacancies, the remaining vacancies will be reverted to open competition and filled by the other successful candidates, observing the ranking order in the selection process and distribution among the lines.
- 9.5 If the places allocated to indigenous and quilombola candidates are not filled, they will be canceled and cannot be reverted to the open competition.
- 9.6 Candidates who are socially recognized as black, in accordance with CEPE Resolution 090/2022, will be considered black.
- 9.7 Candidates opting for affirmative action policies for black people must undergo a heteroidentification procedure to validate their self-declaration, in accordance with CEPE Resolution no. 090/2022.
- 9.8 Adherence to this modality will be voluntary by filling in the specific self-declaration form available in the notice to be sent via the electronic registration system.
- 9.9 Self-declared black candidates will be able to compete in the broad competition and reserved vacancies modalities, i.e., black candidates will compete simultaneously for the reserved vacancies and the vacancies allocated to the broad competition.
- 9.10 Black candidates enrolled in the affirmative action policy, and who obtain sufficient marks to be approved within the number of places offered in the broad competition system, will fill the vacancies in this system, thus opening up the vacancy reserved by the affirmative action policy to the black candidate subsequently classified.
- 9.11 Candidates recognized as indigenous and quilombola will be considered as such.
- 9.12 Adherence to this modality will be voluntary. To do so, you will fill out a specific self-declaration form to be sent via the electronic registration system.
- 9.13 Candidates opting for affirmative action policies for Indigenous people will have their self-declaration confirmed by the Hetero-identification Commission of the Postgraduate Dean's Office. The commission will assess a letter signed by an Indigenous leader or organization acknowledging the candidate and their link to the Indigenous group, in accordance with CEPE Resolution no. 090/2022.

- 9.14 Candidates opting for affirmative action policies for quilombolas will have their self-declaration confirmed by the Hetero-identification Commission of the Postgraduate Dean's Office. The commission will assess a letter signed by a leader or organization acknowledging the candidate and their link to the quilombola group, in accordance with CEPE Resolution no. 090/2022.
- 9.15 People with disabilities are those who have a long-term physical, mental, intellectual, or sensory impairment which, in interaction with one or more barriers, may hinder their full and effective participation in society on equal terms with other people.
- 9.16 Adherence to this modality will be voluntary. To do so, fill in the specific self-declaration form available in Annex XI and send it via the electronic registration system.
- 9.17 If a candidate with a disability who has been approved for an additional vacancy withdraws, the vacancy will be filled by the candidate with a disability ranked in descending order of final grade.
- 9.18 If there are not enough successful candidates with disabilities to fill the reserved places, at the PPG's discretion, the remaining places will be allocated to the Affirmative Action Policy, with the PPG deciding which segment will be served (black, indigenous and quilombola).
- 9.19 If the admission criteria are not met, the vacancies may be reused in the general selection process or disregarded, with the decision being taken by this Graduate Program, through a Collegiate decision, according to CPP Resolution No. 0005/2020.
- 9.20 Self-declared black, indigenous, quilombola, and disabled applicants must complete and submit a Self-Declaration to apply for the Reserved Seats for Black or Indigenous Applicants or Quilombolas or People with Disabilities (models in Annex VIII to XI).
- 9.21 In the case of indigenous candidates, confirmation of self-declaration (annex IX) will be based on the presentation of the Declaration of Belonging to the Indigenous Community signed by an indigenous leader or organization (annex XII), acknowledging the candidate and their link to the indigenous group by the deadline set in the notice, in accordance with CEPE/UnB Resolution 0044/2020, available in the notice to be sent via the electronic registration system.
- 9.22 In the case of Quilombola candidates, confirmation of self-declaration (annex X) will be based on the presentation of the Declaration of Belonging to the Quilombola Community signed by a Quilombola leader or organization (annex XIII), acknowledging the candidate and their link to the Quilombola group by the deadline set in the notice, in accordance with CEPE/UnB Resolution 0044/2020, available in the notice to be sent via the electronic registration system.
- 9.23 Once classified in the selection process, the self-declared disabled candidate must, at the time of enrolment in the Postgraduate Program in Medical Sciences, prove their condition through a medical report.
 - § Paragraph 1: The medical report must have been issued no more than 6 (six)

months before the publication of the Public Notice.

- § Paragraph 2 The medical report must contain
- I The doctor's signature, stamp, and registration number with the Regional Medical Council;
 - II Specification of the degree of disability.
- 9.24 In the event of the withdrawal of black candidates approved for reserved places, the reserved place not filled will be occupied by the black candidate subsequently approved in accordance with the ranking order.
- 9.25 Candidates who opt for the specific vacancy for people with disabilities (item 2.5) and fail to prove their disability will be eliminated from the selection process.
- 9.26 Transsexuals and transvestites will be considered to be candidates who declare themselves as such when registering for the selection process. Adherence to this modality will be voluntary by filling in a self-declaration form, according to the model in Annex XIV. Transvestite and transsexual candidates may indicate their social name in the field provided on the application form, provided they present a supporting document.
- 9.27 Whenever scholarships are available and in accordance with the criteria of the funding agencies, they will be distributed as a priority in the following order:
 - I. Indigenous and quilombola candidates;
 - II. self-declared and hetero-identified black applicants opting for affirmative action policies;
 - III. candidates with disabilities;
 - IV. transsexual or transvestite candidates;
 - V. other successful candidates.

10 FINAL PROVISIONS

- 10.1 The candidates will be disqualified and automatically excluded from the selection process if:
 - 10.1.1 Make false statements or present false documents at any of the selection stages;
 - 10.1.2 Do not submit all the required documentation by the deadlines and under the conditions stipulated in this Notice;
 - 10.1.3 Fail to confirm their participation in the Program on the date specified in this notice, should they be selected.
- 10.2 Omissions will be resolved by the Selection Committee, the Graduate Program Board, and the Graduate Dean's Office in accordance with the Program regulations and CEPE Resolution 080/2021, following their competencies.
- 10.3 At the discretion of the selection committee, vacancies may be reallocated from one line of research to another or from the Master's course to the Doctorate course and vice



versa, as the case may be, as long as there are candidates approved under the terms of this notice. If the candidate residing abroad vacancy is not filled, it may be filled by a candidate living in the country, respecting the ranking order.




